This seminar provides a complete overview of the rule as well as information on how to ensure compliance and maximize the PHAS score. Faculty will discuss the rule, highlighting additions and key changes. In addition, they will provide a step-by-step walkthrough of the system using actual PHA data to provide participants with a real-life example of the new assessment system.

Housing inspectors, preventative maintenance inspectors, and new and veteran inspectors.

NAHRO Approach to Training

NAHRO will provide inclusive training through short lectures and case studies. NAHRO's case study approach will enable the participant to have multiple methods of learning through practice examples. These techniques include:

- An in-depth explanation of the rule, regulation, policy or definition;
- Realistic case examples that bring the forms to life and allow for meaningful practice;
- Engagement of participants through both group and individual exercises;
- Allowing participants to ask questions from their own experiences and addressing issues that have directly impacted their agency; and
- Allowing participants to explain solutions and how they applied the regulation to the case example
